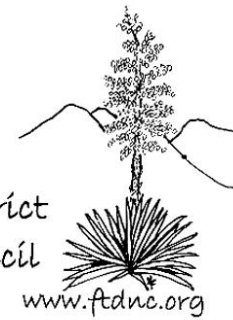

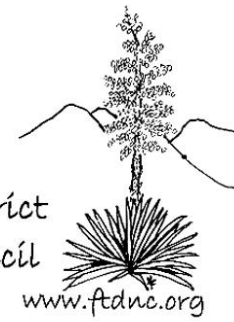
### **PROCESS FOR RECONSIDERATION**
